### Contract declarations

#### General contractual declarations of entrant/team, driver (entrant/team, driver = participant).

The participants are jointly and severally liable for all obligations arising from the entry contract.

The participants assure that

- » the information provided in this entry form is correct and complete,
- » they are fully capable of meeting the requirements of the Formula Winter Series event(s),
- » the vehicle complies in all respects with the relevant technical regulations,
- » the vehicle can be inspected in all parts by the Technical Commissioners at any time, and
- » they will only use the vehicle in a technically and visually perfect condition at the respective Formula Winter Series event,
- » they are bound by the International Sporting Code (ISC) of the FIA (Fédération Internationale de l'Automobile) with its appendices, the legal and disciplinary regulations of the FIA, the anti-doping regulations of the World and National Anti-Doping Agency (WADA/NADA Code), the relevant RFEDA regulations, the General Championship Regulations and the Special Series Regulations, the Formula Winter Series General Regulations and the Formula Winter Series Technical Regulations, the RFEDA Legal and Procedural Regulations, the RFEDA Environmental Guidelines and the other FIA and RFEDA regulations, and you acknowledge that they are binding on you and that you will comply with them.

In particular, you acknowledge as binding that

- » they must accept facts in the person or behaviour of a team member (competitor, driver, co-driver, mechanic, helper, etc.) which affect the contractual relationship with the organiser of the Formula Winter Series or give rise to a claim for damages, for and against themselves,
- » the RFEDA, its jurisdiction, the stewards, the race director and the Formula Winter Series organiser - each within their competence - are entitled to impose penalties, in addition to other measures, for breaches of the sporting rules, sporting regulations and contractual obligations, the regulations, invitations to tender and other provisions,
- » they may not use substances or methods as defined in the Prohibited List of the WADA World Anti-Doping Code and the FIA Anti-Doping Regulations.

#### Protest and Appeal Power of Attorney

The participants (also several drivers named for one vehicle) authorise each other with this submission of the entry to represent the other in the protest and appeal procedure. In particular, they authorise each other to submit protests, to withdraw, announce, file and confirm them, to withdraw and waive appeals and to file all motions possible within the framework of the protest and appeal proceedings as well as to make or receive declarations.

#### Declarations of the participants on the exclusion of liability

Participants take part in the Formula Winter Series event(s) at their own risk. They bear sole responsibility under civil and criminal law for all damage caused by them. They declare the waiver of claims of any kind for damages arising in connection with the Formula Winter Series event(s) against

- » their own participants (other agreements between the participants take precedence!) and helpers,
- » the respective other participants, the owners and keepers of all vehicles participating in the Formula Winter Series event(s) (insofar as the event(s) takes place on a permanent or temporarily closed track) and their helpers,
- » the FIA, RFEDA, the member organisations of RFEDA, their presidents, officers, directors and general secretaries, agents, employees and members,
- » The promoter, series organiser of the Formula Winter Series, Gedlich Racing GmbH, its directors, officers, agents, employees and members,
- » the sports officials and helpers, the race track owners, the legal bodies of the authorities, racing services and all other persons connected with the organisation and running of the Formula Winter Series event(s),
- » the road authorities, and
- » the vicarious agents, the legal representatives, the organs, the representatives, the full-time and honorary employees of all the aforementioned persons and bodies as well as their members.

The waiver of liability shall not apply to damages resulting from injury to life, body or health, to other damages based on a wilful or grossly negligent breach of duty or to damages resulting from the breach of a material contractual obligation by the person liable.

contractual obligation by the group of persons liable. In the case of damage caused by a slightly negligent breach of essential contractual obligations, liability for financial loss and damage to property shall be limited to the amount of the typical, foreseeable damage. The waiver of liability shall apply to claims based on any legal grounds, i.e. in particular to claims for damages based on contractual and non-contractual liability and to claims based on tort. Tacit exclusions of liability shall remain unaffected by the above exclusion of liability clause.

By submitting their entry form, the participants acknowledge that insurance cover under the motor vehicle insurance policies (motor vehicle liability, comprehensive and passenger accident insurance) will not be granted for damage occurring in the course of the Formula Winter Series event(s) aimed at achieving top speeds. You undertake to also inform the keeper and the owner of the vehicle used thereof.

#### Release from the duty of confidentiality

In the event of an injury occurring or being detected in the course of the Formula Winter Series event(s) or in the event of damage to health which may permanently or temporarily call into question the fitness for motor sport, the undersigned releases all attending doctors - in view of the safety risk resulting not only for him/herself but also for third parties - from the medical confidentiality obligation among themselves as well as towards the Race Director, the Race Director(s), the Sports Commissioner(s), the Chief Race Doctor, the Medical Officer and the Insurance Claims Office.

Your data is processed on the basis of a legitimate interest of RFEDA and the Formula Winter Series. The purpose is to protect licensees at sporting events. You can object to this processing at any time with effect for the future.

RFEDA, its member organisations and the organiser of the Formula Winter Series do not participate in dispute resolution proceedings before a consumer arbitration board in accordance with the Consumer Dispute Resolution Act.

#### DECLARATION OF EXEMPTION FOR FILM/PHOTO PRODUCTIONS AND DATA PROTECTION INFORMATION

The participant declares his consent to the carrying out of photographic and filming work during the Formula Winter Series event(s) and to the granting to the organiser of the Formula Winter Series of the free broadcasting, public reproduction, recording, duplication and editing rights with regard to the film or photographic recordings made of him, any accompanying persons or their vehicles. In addition to the use for reporting on the race, the participants and the results in print, radio, TV and online media, such as in particular the Internet/Facebook sites of the organiser of the Formula Winter Series, the granting of rights also includes the use of the recordings for purposes of self-promotion or event advertising. If the participant sends photographic material to the organiser of the Formula Winter Series, the participant also declares his/her consent to the unrestricted use, exploitation or publication by the organiser of the Formula Winter Series free of charge.

I further agree that the organiser of the Formula Winter Series may use my data collected in the application and registration/entry forms for the following purposes:

Publication (including on the internet) of lists of participants and results and of decisions of the Race Director and the Race Director(s), as well as of the Stewards and, if applicable, subsequently of the Association Courts, as well as transmission of the documents to RFEDA and its member organisations.

The waiver of liability applies to claims based on any legal grounds, i.e. in particular to claims for damages based on contractual and non-contractual liability and to claims in tort.
