- ▶ The number of disqualifications or penalties given by the Stewards due to technical non-compliance or sporting infringements directly caused by the team in any championship the candidate has taken part;
- ▶ The acceptance of sporting and technical decisions concerning FORMULA WINTER SERIES races, as well as any other race, from any other championship, the candidate has taken part in;
- ▶ Compliance with all deadlines (payments of entry fees; sending of the fully signed participation contract).
