



## PARKING LIABILITY WAIVER AND AUTHORISATION

I know that this agreement is a release of responsibility with regard to all and any claims and compensations, and a compromise between myself and Fira Circuit S.L.U., Circuits de Catalunya, S.L. and the Consortium of the Circuit de Barcelona -Catalunya, and/or its employees or persons providing services to these companies.

**Parking Rate: €35 + VAT per day and vehicle.**

### Conditions:

- Rates are per day and do not include power supply.
- Access allowed on arrival and departure dates only, from 09:00 to 20:00. No arrival or departure will be allowed out of this schedule unless previously requested and authorised by the Circuit Security Department. Additional fees may apply.
- Collecting the vehicle later than the authorised date will have a penalty of €100 per day and vehicle.
- Payment will be made before arrival. No truck will be allowed without having paid for the full amount of the stay.
- Parking your vehicle without the Circuit's authorisation will have a penalty fee of €100 per day and vehicle.
- Parking spaces are limited, and no trucks will be allowed when the truck parking will be at full capacity.
- The Circuit reserves the right of admission to parking at any time



This document is not a valid authorisation parking permit unless authorised by the Circuit de Barcelona-Catalunya Security Department. Once authorised, your vehicle will have to park in the allocated parking spot.
